KENYAN GENOCIDE & MASS RAPE:

PROSECUTOR V. JEAN PAUL AKAYESU (ICTR-96-4-T)

Mr. Ocampo, I address you today to write about the Kenyan Genocide and the Mass Rape Incident that was witnessed here.

CSI Nairobi (part of **DNA TESTING SERVICES**) together with the **Nairobi Women's Hospital** collected DNA samples from sexually assaulted women and children. These samples were shipped to the world's most respected private DNA Forensic facility in the U.S, **Bode Technology Group** for analysis and profiling.

Kibera, Mathare, Huruma, Pipeline, Karen, Kasarani and Dandora.

CSI Nairobi has sufficient DNA evidence indicating that these were the key areas in Nairobi which experienced mass rape during the post election violence.

Under the United Nations Resolution 1820 (2008), rape and other forms of sexual violence can constitute a war crime, a crime against humanity, or a constitutive act with respect to genocide.

If the Kenyan rapes were systematic, the responsibility will be borne by the politicians'

affiliated to the areas affected or by prefects who are deemed to control force... whether they participated or not, as was the case with Mayor Akayesu of Rwanda who was jailed by the ICC for life despite his defence that he did not participate in the rapes.

From the hard evidence in our possession, we wish to categorically state that the above named individuals were **NOT** in any way, by acts of omission or commission or otherwise, responsible for the mass rape that was witnessed **specifically in Nairobi, Kenya.**

The rapes in Nairobi **DID NOT TARGET ONE ETHNIC GROUP.** Indeed, all women from all ethnic groups in Nairobi were in danger from opportunistic rapists.


The Prosecutor v. Jean Paul Akayesu (ICTR-96-4-T)
